## 2019-2020 BACK TO SCHOOL - FREE SALES AND USE TAX HOLIDAY PERIOD

The Puerto Rico Treasury Department (PRTD) issued Internal Revenue Circular Letter No. 19-11 (IR CL 19-11) to announce that the Back to School free sales and use tax holiday period for the fiscal Year 2019-2020 will be:

- July 12, 2019 to July 13, 2019.
- January 3, 2020 to January 4, 2020.

## **EMPLOYEE RETENTION TAX CREDIT EXTENSION**

The PRTD issued an Internal Revenue Informative Bulletin No. 19-07 (IR IB 19-07) to extend the eligibility period to request the Employee Retention Tax Credit (ERTC) until June 30, 2019.

Furthermore, IR IB 19-07 extended the period to file a claim for benefit, as provided in Circular Letter No. 18-20 (CL 18-20), to July 10, 2019.
